Some schemes under DRDA benefits individual like SGSY and IAY, while other benefit community or individuals. Brief writeup scheme wise is given below; details may be ascertained from DRDA / BDOs concerned.

(i) **Name of Scheme :-** SGSY

Objective of the Programme:-To bring the assisted poor families (Swarozgaries) above the poverty line by providing them income generating assets through a mix of bank credit and government subsidy.

Physical & Financial targets of the Programme (for the last year)

Eligibility of beneficiary:- Any person individual or groups living below poverty line is eligible.

Pre requisites for the benefits :-The individual/beneficiary is first to be identified/selected through a selection by the banks & DRDAs Officials and after that it is to be approved by the Block SGSY Committee. In respect of SHGs, the group must pass the grading exercise.

Procedure to avail the benefits of the Programme: - Submission of application to the BDOs Office and the same is forwarded to Banks for sanction for disbursement of the assistance.

Criteria for deciding eligibility :-The person is to be a BPL. If it is a SHG, the SHG is to satisfy all the grading exercise conducted by the BDO/DRDA and the Banks

Details of the benefits given in the programme (also mention the amount of subsidy or other help given).

Subsidy is given at 30 % of the project cost subject to a maximum of Rs.7500.00. In respect of SC/ST 50 % and Rs.10, 000.00 respectively. For groups (SHG), the subsidy would be at 50 % of the cost of the scheme, subject of Rs.1.25 lakhs.

Procedure of the distribution of the subsidy :- The subsidy is sanctioned and disbursed by Banks to the Beneficiaries.

Where to apply or whom to contact in the Office for applying :- Contact the district rural Development Agencies in the District and the Block Development Block.

The beneficiary will get Rs. 100/- per month as a pension.

Financial target for the year 2004-05 was Rs 60.50 Lakh. The Physical target was 605 numbers.

Eligibility of beneficiary :- A family living below poverty line, in the event of the death of its breadwinner.

Pre requisites for the benefits :- The beneficiary is first to be identified by the Block Development Officer along with the help of the Headman/Nokmas.

Procedure to avail the benefits of the programme :- The beneficiary selected is to be approved by the District Level Committee on NSAP.

Criteria for deciding eligibility :- Any BPL families on the death of their primary bread earners, having an age group of 18 years to 64 years.

Details of the benefits given in the programme (also mention the amount of subsidy or other help given)

The bereaved family will get lump sum amount of Rs. 10,000/-.

Procedure of the distribution of the Subsidy :- The Deputy Commissioners/Block Development Officers will disburse the assistance to the beneficiary.

(vii) **Name of Scheme** :- Assistance to Small and Marginal Farmers (ASF/MF)

Duration of the Programme/Scheme:- Continuous Scheme

Objective of the Programme :- It aims at increasing agricultural products by way of providing irrigation facilities, land reclamation, manuring etc.

Physical & Financial targets of the programme (for the last year).

Financial target for the year 2004-05 was Rs. 100.00 lakhs.

Eligibility of beneficiary :- The beneficiary should be small and marginal farmer.

Pre requisites for the benefits :- The beneficiary should either be an owner or cultivator of a land holding of the prescribe size.

Procedure to avail the benefits of the programme :- The farmers/ areas will be first identified by the Blocks to be taken up as the project under ASF/MF. The project/ beneficiary will be approved by the District Level Committee/ Governing Bodies of DRDA before implementing.

Criteria for deciding eligibility :- The small farmers with holdings of less than 2 htc. Marginal farmers with land holding of 1 htc.

The beneficiary will get the required amount of subsidy as per the 50% of the project cost. 50% is to be contributed by the beneficiary.
